

- Provides a stable income to assist with hiring staff



#### Samvera Governance Review Report, 2020

August 2020

In April 2018, the Samvera Partners adopted the <u>recommendations</u> from a Governance Working Group that it had commissioned; these recommendations made a number of significant changes to the way in which the Samvera Community operates. The final recommendation called for a review at the end of 2019, to ensure that the governance recommendations are meeting the Community's needs. Partners deferred this assessment until the beginning of 2020.

A small group (Chris Awre, Eand Cowles, Richard Green, Bran McBride, Margaret Mellinger) was formed to conduct the review, to determine whether or not governance recommendations are satisfying Partners, and to recommend next steps. To gauge satisfaction with the implementation of the governance recommendations. He small group developed a set of questions to be answered, delivered an exercise at the Spring Samvera Partner meeting with a tlandees, and distributed a follow-up survey to partners and 39 other potentially interested parties. This report communicates the result of those activities, offers some next steps, and serves as the cultimation of the small group's work.

Assessing Progress on Governance Recommendations

These are the recommendations from the Governance Working Group

- 1. Steering will become an elected body from Partners
- 2. Samvera will hire centralized staff
- 3. Samvera will develop a Contribution Model
- 4. Samvera Partners will establish a Roadmap Council
- 5. Newly established Steering will update Bylaws
- 6. Partners will assess governance at the end of 2019

In accordance with the sixth recommendation, we asked respondents how well Samvera is progressing on the other five. For each recommendation, we asked for one of four responses: a) Just getting started

- b) Making good progress but not yet fully accomplished
- c) Completed and under periodic review
- d) Don't know
- ) Don't know

#### Samvera Technical Coordinator

The Samvera Community seeks a dedicated staff member to serve as a coordinator for its technical development and maintenance work. The person in this role will serve as a facilitator and provisioner of Samvera's software development efforts; an expert consultant on Samvera technology issues for adopters and integrators; and a general resource for helping coordinate and support Samvera's technical components

The Samvera Technical Coordinator will work closely with the Samvera Community Manager who has a major focus on community and communications management. Together, the two post-holders will provide support for all aspects of the Samvera Community's work.

The incumbent will report to the Chair (or the Chair's designate) of the Samvera Steering Group who will provide high-level direction. A number of employment models may be considered in discussion with candidates including direct employment by Samvera's fiscal sponsor (Lyrasis), Independent contractor relationship, employment by Samvera Pattner institution, or as a grant to an existing organization, with an agreement to second the employee to Samvera, if the candidate wishes to remain with his or heir institution. The details of precise working conditions will depend on the model chosen but remote working is assumed.

Travel is required. Candidates may be located anywhere in North America or Western Europe. Salary dependent upon qualifications; benefits dependent upon employment model.

Specific duties include:

#### Facilitate and provision Samvera's software development efforts

This includes a combination of guiding and participating in software development. The Technology Coordinator will provide leadership in conjunction with Samvera Community's several development advisory and support groups.

Duties will include:

 developing and nurturing relationships with key stakeholders whilst fostering an environment of collaboration, trust and accountability;





# **Stats about contributors\***




#### Number of Contributors
